FROM THE PRESIDENT – Paul Glynn - To All Members

I have had a lot of farmers, livestock contractors and graziers come to me say they would like to buy these well trained dogs but have a question mark on would they do the job on a property. This sport came around from graziers competing to see who had the best dog let's not loose site of that. Just a little information regarding the 2015 Supreme;

Date: 12th to 18th October, 2015

At: Campbell Town

Notes: The “Spirit Of Tasmania” are still holding Caravan Spaces for Dog Trialers until the 21st July, 2015. So book now if you are planning the trip.

Trialers need to treat dogs for hydatid tapeworms within 14 days of going to Tassie and they need proof of that Dronci treatment was administered. Handlers also need to have their cages approved by a Vet. Handlers flying to Tassie need to have dogs wormed by a vet within 14 days and a Vet Certificate for proof.

Due to the high numbers of Trialers expected there is a little concern regarding power so if you are able to bring a generator please do so as it may be needed as a backup.

Compulsory Liability Clause – Insurance 2015

All Trial Entry Forms will from have the following liability clause noted due to our new Insurance regulations.

Iacknowledge that working with sheep may put me at risk of illness or injury and that in attending this trial I accept that I may be injured from both foreseen and unforeseen events associated with working sheep and dogs. I will not hold NSWSDWI, the committee or any member of the association responsible for any illness or injury that may occur as a direct or indirect result of attending this trial.
