You can also print off pedigrees to new puppy owners, keep your own records or many other really handy things that a breeder or trialler might want when looking for breeding stock. I am always available to chat about a pedigree or if you want, so please feel free to give me a ring if you have any questions. Also, if you find a mistake in your pedigree, give me a ring or email and I will make sure we fix it up so that it is correct.

Please remember when selling a dog or purchasing a dog or a pup or at time of mating bitches to stud dogs to get the appropriate paperwork filled in. A form is in this newsletter and also you can download one from our website or ring me and I will send you out some.

At times a signature may not be easy to get so I can always ring and get conformation. However, and I must stress this.... the signature is not a form of blackmail by any member/s. Please remember that we have a code of practice which asks for good sportsmanship. Should a member have stipulations on registration of dogs from a stud dog or a litter, you, as the owner need to formally do a written contract with the other owner of the dog so that both parties know what is required of them. .

Congratulations to Mick Hudson and Bill Davidson who will be representing NSW at the upcoming Supreme in Western Australia in October. Good luck!

The following report was sent to us by Jon Cantrall:

The NSW State Selection Trial was run in some trying weather conditions at the Eumungerie Showground on the 3rd and 4th of June. When asked of the wettest trial he has attended, Mick Hudson's reply was "this one!".

Despite the persistent rain, the trial ran very smoothly. The standard of trialling was excellent with some of the best dogs and handlers in NSW competing and it was a pleasure to watch from the sideline. Everyone present helped run the trial, this was demonstrated by every competitor. Once their run was finished, they would take their sheep off, and then stay in the let out yards for two or three runs. This kept the yards running smoothly and also meant no-one got stuck down there. Great idea Paul!

There were many comments on the Judges, Mr Peter Oxley and Mr John Perry, and these comments were on the high and consistent standard in less than favourable weather. Throughout the whole trial the scores from both judges were within a point or two of each other.

Over the first round, top twenty and top ten, Mick Hudson from Eumungerie prevailed as the winner. Over three rounds, Mick and MGH Jana only lost 15 points out of a possible 300.
