The heats will be run on Thursday and Friday and the top 10 dogs on Saturday morning in the Semi Final and top 5 dogs in the final on Saturday afternoon. The novice section will be run on the Saturday.

Prize money and trophies will be offered for placegetters in the Trial, distributed as follows:

***1<sup>st</sup> - \$500 + trophy; 2<sup>nd</sup> - \$300 + trophy; 3<sup>rd</sup> - \$100 + trophy;***  
***4<sup>th</sup> - Prize 5<sup>th</sup> - Prize Novice - Prize***

When nominating to be a Worker, we ask that you nominate your dogs in running order. A nomination fee of \$15.00 will apply for each dog entered. Rules for the Three Sheep trial will in accordance with the Rules of NSW Sheepdog Workers Incorporated and will be a 15 minute trial. There will be disqualification from the Judge or voluntary retirement for out of control trialling.

A final list of dogs participating will be issued to all Workers, as soon as possible after the nomination closing date along with entrance tickets to the Field Days event where the trial will be held.
