CONDITIONS

1. Worked under the rules of the NSWSDWI.
2. All dogs entered in Encourage, Novice, Improver and Open Trials must be registered with the NSWSDWI or a similar kindred body.
3. All workers must be a member of the NSWSDWI or a similar kindred body.
4. Workers must work dogs in order as entered on the entry form.
5. The draw will be strictly adhered to.
6. In the event of a tie for first place in the Championships, a run-off will be run to determine a winner.
7. **Entry fee must accompany entries.** Cheque payable to Molong Sheep Dog Workers Committee or Direct Deposit.
8. Open dogs must have won an advertised trial.
9. Late entries will be received up to 9th March, 2021 for an additional Entry Fee 1 ½ times normal fee, dogs to be worked at the end of each round.
10. Rule 57 will apply - if required.
