## HENTY MACHINERY FIELD DAYS

### Course:

The trial will be run under the NSWSDWI rules. Judge: Mr Kenny Robinson.

### Trial information:

The Henty Sheepdog Trial commences on Tuesday 19<sup>th</sup> September 2023. This is the Tuesday following the completion of the ASDWA Supreme held in Strathalbyn S.A. Competitors, please note it is approximately 840km from Strathalbyn S.A. to Henty NSW.

### Trial Schedule:

The Trial is run in conjunction with the Henty Machinery Field Days, running from 19-21<sup>st</sup> September 2023. Rounds will be run on the Tuesday and Wednesday with Finals to be completed on the Thursday.

The committee will do their best to work with all competitors returning from S.A. to avoid missing their runs.

### Camping:

Camping is available at the Henty Showground and Yerong Creek Showground.

### Entry fees:

\$20 entry fee per dog. All entry fees must be made by direct deposit only, prior to the trial.

A maximum of 4 dogs can be nominated per handler. The committee reserves the right to restrict the number of dogs. Should dog numbers be restricted due to high number of entries, please nominate a dog (mark with X) to be eliminated if required. Entry fee will be refunded if any dog is eliminated.

Only registered dogs are eligible, and any dog substitution must be made before the trial commences.

This trial is an Open trial. Encourage, Novice, Improver, and Open dogs will be accepted.
